Dear Cajun Cook-off Merchandise and Packaged Food Vendor,

Below is the application for the 2019 Jonestown Cajun Fest. This is a one-day event on April 13, 2019 and will be held rain or shine. Admission to event is free. Parking is \$5 for attendees, free for vendors.

- 1. Booth Fee is \$75.00 per booth (Chamber members \$50)**
Booth space is 10 x 10 feet located along a sidewalk. All spaces are located outdoors. Tents are preferred but not required. Booth spaces will be filled on a first-paid, first reserved basis. We will not be offering exclusives. There will be no provision for electricity or water.
- 2. Restrictions:** All booths must offer an item to sell. Sale of non-alcoholic beverages is allowed. No weapons, guns, plastic toy guns, fireworks, or games of chance are permitted.
- 3. Event time and set-up:**
Event begins with parade in park at 11:00 a.m.
Event set-up hours are: 8:00 a.m. – 10:30 a.m.
Take down begins at 7:00 p.m.

Vehicles will be permitted in area for unloading but must be moved to vendor parking area. No vehicles will be allowed in exhibit area during event hours.
